Submissions are invited from across the UK and beyond <u>until 4 February</u> and you can respond easily through an online questionnaire or can write by following the instructions on the APPG website. *Some thoughts to help you can be found here* and a briefing for supporters in Northern Ireland about the clause in Lord Morrow's Bill which also criminalises paying for sex can be found *here* and might also be useful"
